PennEnvironment Virtual Climate Action Event

The Energy Co-op is a cooperative that supplies sustainable, affordable energy to its members, not an advocacy group. So, we do not engage in



lobbying efforts or directly engage with elected or appointed government officials on policy matters.

But two Energy Co-op staff members—on their own time and in their own interest—participated last month in the first-ever <u>virtual action day organized</u> <u>by PennEnvironment</u>, a Pennsylvania-focused environmental advocacy organization. Alexandra Kroger, The Energy Co-op's renewable energy program's director participated on behalf of the Philadelphia chapter of Women in Renewable Industries (WRISE), and Bryan Hutchinson, our staff accountant, took part to support causes of personal importance to him. The event, which took place on June 16th, featured virtual meetings with state representatives and senators, and their staff members, to advocate for legislation that will help fight climate change.

Alexandra met with state Representative James Roebuck and a staff member from the office of state Senator Vincent Hughes. Together with several other constituents, she thanked the legislators for their strong, reliable voting records in support of environmental and climate change-focused legislation. Each meeting featured a member of the PennEnvironment staff, who urged the elected officials to support Pennsylvania's plan to join the <u>Regional Greenhouse Gas Initiative</u>, or RGGI. You can read more about RGGI in our recent blog post <u>here</u>.

Bryan's meetings were with his state senator, Thomas Killion, and his state house representative, Carolyn Comitta, and both also focused on RGGI. As PennEnvironment staffers noted during the meeting with Senator Killion, the concept of cap-and-trade—which is the strategy RGGI uses for reducing carbon emissions through tradeable allowances—enjoyed bipartisan support when adopted to address the problem of acid rain during the George H.W. Bush administration. During the meeting with Representative Comitta, participants also asked her to support the House's passage of the Electric Vehicle Infrastructure bill, which had already passed in the Senate.

Their colleagues at The Energy Co-op applaud Alexandra and Bryan both for their civic involvement and commitment to sustainable, renewable energy, and for their great work with us on behalf of The Energy Co-op members.
