Enrolling in The Energy Co-op's renewable natural gas program is a nobrainer.

RNG is mainly methane created when organic waste decomposes. Think landfill, wastewater treatment, farm waste. Our RNG program promotes collection and use of this biogas, thus reducing demand for natural gas recovered by destructive means or, worse yet, wasted by flaring. Less demand, less drilling, less fracking—a cleaner Pennsylvania.

Sure, our RNG program will cost a little more. But we estimate only 50 cents a day more for the average PGW residential account or 90 cents a day more for residential PECO customers. You throw more than that in your change bucket every day.

So, if you're looking for a sure return on investment, don't look to Wall Street. Instead, invest in a cleaner Pennsylvania.

A Warning about Bad Actors in the Energy Industry

In the past few months, we have learned about several of our members being the victims of something called "slamming". Slamming is when an energy supplier enrolls someone as a customer without their knowledge or consent, very often during a telephone call. So, be wary of any calls you receive about your renewable electricity or renewable natural gas service from people claiming to represent The Energy Co-op. Although you can call us whenever you wish, The Energy Co-op will only contact you by telephone about matters pertaining to your existing service or in response to an inquiry you made, not for solicitation.

You should also know that some companies engaged in slamming will even pretend that they represent your utility—like PECO or PGW—and are calling about a problem with your bill or service. Before you know it, instead of sourcing your energy from The Energy Co-op and supporting green energy jobs in Pennsylvania, you're buying who knows what from who knows whom. So, take care when answering those calls. And of course, make sure you carefully read any paperwork that you are asked to sign. If The Energy Co-op is already supplying your renewable electricity or renewable natural gas, we have no reason to ask you to sign anything. Finally, if you believe you've been slammed, please call us at (215) 413-2122 and give some thought to filing a complaint with the Pennsylvania Public Utility Commission.
