Concerned about drilling and fracking? [Join The Energy Co-op for a webinar on an alternative - Renewable Natural Gas \(RNG\)!](#)

Renewable Natural Gas (RNG) is comprised primarily of methane that forms naturally from the decomposition of organic waste in landfills and other waste treatment facilities. It's often flared, reducing it to CO₂ and wasting the energy content of its methane component. However, RNG can also be used like conventional natural gas—but without any drilling or fracking.

Wednesday, April 14 @ 4:00pm – [Solar PPAs in Pennsylvania: A WRISE presentation](#)

In recent years, Pennsylvania has been GOING SOLAR in a big way. With government initiatives like Governor Tom Wolf's recent commitment for the state to purchase half of all electricity used by Pennsylvania's government buildings from solar energy arrays, and similar commitments by the government and agencies of Philadelphia, there's a lot of solar installation on the way!

This month, the Philadelphia Chapter of WRISE is fortunate to have a special speaker who is an expert on a specific financial structure that is enabling this significant expansion of solar energy in our state. Rebecca Collins, Director of Sustainability at Temple University, will be speaking about her experiences introducing the concept of the solar Power Purchase Agreement (PPA) to leadership, balancing economic goals and carbon emission goals, and negotiating both Virtual and Physical PPA contracts. Rebecca's renewable energy portfolio includes a 3 MW onsite solar project in Philadelphia and a 40 MW off-site solar project in Franklin County.

Saturday, April 17 – [40th Annual Run for Clean Air](#)

2021 is a huge landmark for the Run for Clean Air, commemorating the 40th anniversary of the race. The Run for Clean Air is one of the region's longest-running charity races and its largest Earth Day event. The Run is a celebration of sustainable and healthy neighborhoods, clean air, and improvements in the region's overall environmental health. Year after year, sponsors, volunteers, runners, walkers and families choose to celebrate Earth Day with Clean Air Council.

For a second year, the Run for Clean Air will be a [virtual race](#), giving runners the freedom and flexibility to run their race when and where they like. All virtual runners and walkers will receive a race shirt and finisher medal.
