## **Important Updates on Energy Market Conditions**

As we prepare to shift from a mild and pleasant autumn into cooler weather, we know winter heating bills are on many of our members' minds. Last month, The Energy Co-op published a new blog post authored by Executive Director Divya Desai and Member Services Manager Noah Swistak, <u>Energy Market</u> <u>Uncertainty & Pennsylvania's Renewable Energy Future</u>, that reviews current conditions in the markets and what we can expect in the coming months.

While everyone is encouraged to read the article to further develop their understanding of current energy market uncertainty, below are some of the key points outlined in the piece:

- Wholesale natural gas prices, which impact the cost of renewable electricity, remain not only <u>far above average</u>, but remarkably volatile as well.
- Natural gas futures prices <u>surged earlier in 2022 and remain high</u>, with prices in the summer hitting highs not seen in years.
- There may be relief on the horizon next year, however, as futures prices drop starting in March 2023, with <u>stabilization predicted throughout</u> <u>next spring</u>.
- While the passing of the landmark Inflation Reduction Act in August 2022 will not abruptly bend energy cost curves downward, it better positions the country to address many of the medium- and long-term climate goals set by states and cities.
- Pennsylvania could benefit from new legislation enabling renewable energy development, which you can support in next week's elections by voting for candidates that support a path towards a clean energy future.

## **Tips to Lower Your Energy Bills This Winter**

With winter right around the corner, now is an ideal time to take steps to improve your home's energy efficiency. Reducing your energy use during the heating season means saving money on your utility bills – of high importance given the market conditions discussed above.

In October, Energy Co-op member Phil Coleman presented a Member-to-Member Webinar <u>"A Few Easy Steps to Lower Energy Bills and a Reduced</u> <u>Carbon Footprint</u>". Check out his presentation and Q&A session with other members for tips on saving energy this winter and year-round.

This <u>quick guide from the NRDC</u> features a number of valuable winter-specific tips for reducing your energy waste and cutting your heating bill. Recommendations include sealing and caulking around doors and windows, lowering the temperature on your water heater, and turning down the thermostat at night and while you're away.

<u>Weatherization Assistance Programs</u> exist across PA to help lower-income residents with free home energy audits and weatherization services. Find the agency that serves your county and <u>determine your eligibility here.</u>

## **Community Spotlight: Philadelphia**

The next entry in our Community Spotlight series, in which we check in about what's new and exciting with renewable energy and sustainability in our members' towns and neighborhoods, focuses on Philadelphia. Let's have a look at what's been happening over the last few months.

The Northeast Philadelphia Airport took initial steps to build a 1.5-megawatt solar array on its property, which would be one of the largest projects in the city and provide enough electricity to power the entire airport. City Council passed a bill approving <u>the project</u>, which was <u>signed by Mayor Kenney</u> in June. Jessica Noon, Sustainability Program Manager for the Capital Development program at Philadelphia International Airport, has also indicated that their team is <u>looking into opportunities</u> for an installation at Philadelphia International Airport.

Down in South Philly, PIDC released the <u>2022 Navy Yard Plan</u>, a 20-year, \$6 billion development roadmap for the 1,200-acre site. The Plan calls for the construction of a new transmission substation that would support additions to the Navy Yard's existing 19 MW of onsite generation, which includes solar. There is also a call for further study of the viability of utilizing thermal technologies on the site and offers one potential siting for a thermal exchange system.

And, if you're like me and aren't certain what to do with those decorative pumpkins, now's a perfect time to familiarize yourself with Philadelphia Parks and Recreation's <u>Community Composting Network</u>. Launched earlier this year, residents can now drop off organic waste, including those <u>Halloween jack-o-lanterns</u>, at thirteen locations around the city.
